#### CHAIRMAN'S REPORT BY BRIAN LONGMAN

THE RIDDLESDOWN RECORDER

This year has been a busy year for the Association with а steady stream of contentious planning applications. With Croydon under pressure to meet its housing target, we have seen a number of developers targeting Riddlesdown and Sanderstead, as an area ripe for redevelopment. This has led to a number of contentious planning applications to demolish existing detached houses and build flats. To date most of the applications for flats in Riddlesdown have been approved, despite our objections. So far, however, no flats have been built.

Whilst the Association is not in principle against the building of flats, many of these applications are for up to 8 flats with parking for 8 cars (or fewer) in the gardens. They are just too big for these relatively small sites. We are seeing applications, with flats in the roof space, flats in basements, flats on land subject to flooding and flats on land subject to restrictive covenants. The only rules appear to be: forget the character of the area, forget the quality of design and any negative effect on neighbours but concentrate on how many flats you can squeeze into a small space! Moving on to another subject, 2018 saw the • Is our current Recorder magazine, website introduction of the new General Data Protection Regulation (GDPR). In brief, all organizations including Residents' Associations, must establish procedures for handling personal information. We need to tell members what personal data we hold and what we use it for. Currently we only hold membership. The Association is certainly one

details of members' names and address and payment of their membership fee. This information is used to record membership and deliver the RRA magazine. Members' personal data is treated as confidential and will not be shared with any other organization. For full details of our personal information procedure, we have published our GDPR Privacy Statement in this edition of the Recorder and it is also on our website.

Remaining on membership but in a different area, the committee are aware of members' changing needs and we have started a general review of membership. Areas to be considered include:

- How can we make it easier for our road stewards to collect the membership fee and deliver the Recorder? In our fast developing cashless society, is collecting £3 in cash the right way forward? Some Associations have moved away from cash to direct debit for collection of membership fees, with mixed results.
- Is the membership fee at £3 set at the right level? Should we consider a single payment for life membership?
- How do we improve communications with residents? Do we need to use e-mail to communicate?
- and Facebook the right model?

At our first committee meeting to discuss some of these issues, the consensus was the personal involvement of road stewards in the delivery of the recorder was key to the success of the RRA and its high level of

Before I move on from membership, one last appeal. We still have no road stewards in Hyde Road. This is a long street, so we are looking for 3 or 4 volunteers to split the road into small easily managed sections. Please give it some thought; you are only looking at say 10 hours a year. Your Association needs you!

No doubt by the time this edition of the Recorder is delivered, you will all be using your shiny new waste and recycling wheelie bins. While the Association was broadly in favour of the new-look recycling service, we did have some concerns. In July, I attended the full Council meeting and asked a couple of questions. Firstly, why was the new large 240litre bin being issued for paper and cardboard, with the current refuse bin (generally 180litre) being reissued for glass and plastic. The smaller wheelie bin was being used to hold what is likely to be the greater volume of recycling. It made no sense to me.

I also asked at the Council meeting: why can't worried abore Croydon have a more bespoke system that get in touch; allowed residents to choice of the bin size they wasteservice required? It should be based on the 8604 7282."

householder's recycling needs, both in terms of capacity and the available space in their garden. Riddlesdown, with its hills and steep gardens can make it difficult for residents to bump large wheelie bins up and down steep steps. The question for Croydon is, what arrangements are they making for residents, especially the frail and elderly, to haul their bins to and from the front of their property?

I have had number of residents contact me who were clearly stressed and upset that they could not cope with the new large and heavy bins and were worried about falling, especially in the winter months. I have to say the response at the full Council meeting on that night, did not fill me with hope. I was, however, pleased that Cllr Stuart Collins agreed to visit Riddlesdown to see the issues for himself. Cllr Collins with a senior Council Officer met us for a walk about, which included talking to several residents. We agreed that certain roads did have issues with steep gardens and steps and a lack of space at the pavement level and he agreed this could be a problem for the elderly and frail. The Councillor and the Officer agreed to take some issues away for immediate action, whilst retaining others for further consideration. They also informed us that the Council was prepared to be flexible and would consider assisted collections if a resident had a genuine problem with the new service.

Should this be the case, then please contact the Council as per the information from their website: "If you received assisted collections in the past, these will continue. If you don't currently have an assisted collection but are worried about moving the new bins, please get in touch; e-mail;

#### PLANNING MATTERS BY PHIL THOMAS

It has been a busy six months on the planning front, with some contentious applications again being submitted and in many cases approved, especially for flats. We summarise the latest applications and also the decisions on some that were reported in the last edition of the Recorder.

#### 141 Brancaster Lane

In mid-July, an application was lodged with the Council for the "erection of a two storey side/rear and roof extensions and conversion into 6 flats with associated parking (4 spaces)." This site is on the corner of Brancaster Lane to Lower Barn Rd and this application is slightly different to the other recent flatted applications. It is intended to abut an existing semi-detached house and not demolish a detached house and replace it with flats. As you can imagine, the adjoining owners in the other half of the semi are extremely concerned about this application.

We believe that this application is inappropriate. unsympathetic and unneighbourly. There will be 3 flats abutting the party wall to 139. One of the flats will be solely within the roof space and will probably be unbearable in hot weather with temperatures in the mid, to high 30's centigrade (unless air conditioning is installed). There will be overshadowing of the twostorey building of the adjoining house at No. 139. The building line of the application site, to the Lower Barn Rd frontage, will be approximately 5m in front of the building line of the adjoining properties in Lower Barn Rd (Nos 132 & 130). Because it is below the 10 flats threshold, no affordable accommodation

has to be provided by the developer.

Only 4 parking spaces are provided for 6 flats. The RRA are concerned in particular by the on-site parking layout, especially at the front of the development. A new dropped kerb and crossover is to be provided at the front of the property onto Brancaster Lane, right on the corner of the Brancaster Lane/Lower Barn Rd junction. We believe this will be a highway safety conflict for both pedestrians and other motorists. There have been many vehicular accidents at his junction, in particular with vehicles exiting from Lower Barn Rd because of poor sight lines with parked vehicles on Brancaster Lane. This footway is also used by many commuters for access to and from Riddlesdown Station and the nearby shops. Pedestrians also cross Brancaster Lane where the dropped kerb is proposed, to walk up and down, to Riddlesdown Ave. In addition, there is an existing crossover in Lower Barn Rd at the rear of the house. To have two crossovers per property is no longer allowed under new Council rules, so we believe this new crossover should not be permitted.

Both the Purley Oaks & Riddlesdown Ward Councillors and the RRA have lodged objections to the Council. At the time of going to print, the application is going to the Planning Committee on 27 September with Officers recommending granting permission. We will post the Council's decision on our website and our Facebook page.

#### **14 Mitchley Ave**

In late July, yet another Aventier application was submitted to the Council to demolish the existing detached house and erect a 4-storey

development consisting of 6 flats with only 4 parking spaces. The RRA are of the view this is another example of the over intensification of a residential area. We have concerns about the parking arrangements with overspill parking happening on both Mitchley Ave and Ingleboro Drive, which is heavily used by Collegiate parents and staff. Both the RRA, the PO&R Ward Councillors and our MP have objected to the Council. Again, we will update you about the decision on our website in due course. As one resident said to us recently: "hopefully, the RRA will also see fit to object as this is getting ridiculous now and turning pleasant suburbia into flatland." If we are not careful, this will happen sooner than we think!

#### 4 Rectory Park

In early February, another application was again submitted by Aventier for 3 twobedroom, 2 one-bedroom and 2 threebedroom flats (7 flats in total) and 6 parking spaces. Aventier already had planning approval for six 2-bedroom flats and 6 parking spaces. However, this seems to be a favourite tactic of Aventier, to apply for initial planning, which is granted and then go back to the Council again to apply for more flats and less on-site parking! In other words, to increase their profit. The RRA and Ward Councillor Tim Pollard objected to this application and the matter was heard at the Planning subcommittee in June. Cllr Pollard and a local resident spoke at the meeting but, despite their valid objections, the application was approved by the Planning sub-committee.

#### **48 Mitchley Hill**

the application has been withdrawn by the applicant. The reasons why, are not known.

#### New Houses Rear of 44 & 46 **Riddlesdown Ave**

Again as I reported last time, two applications were submitted to the Council to regularise applications, where the new houses had not been built in accordance with the previously deposited plans. Croydon Planning Officers decided in mid-August, that both applications should be refused. The Officers agreed that the white walls (instead of yellow stock bricks), the colour of the black windows (instead of white) and the roof tile colours were all acceptable and could remain. However, they did not agree that the construction of the garages (instead of car ports) and to be used only as a refuse and cycle store was appropriate. They thought the garages were over dominant and detrimental to the visual amenity of the street scene. The garages are built so close to the narrow access way that it is very difficult for a vehicle to enter, or exit them! The Officers also said there was insufficient parking for the host property in Riddlesdown Ave with no footway through the rear gardens. The internal ceiling heights and room layout in the houses were also found to be substandard. Refusal was also made on the lack of rain water disposal on the front forecourt. It will be interesting to see what happens next!

#### **NPPF 2018**

On 24 July 2018, the Government published a new National Planning Policy Framework (NPPF) guidelines. It expects all Planning Authorities to adhere to this framework when



NPPF is 'beefed up' in the sense that it raises the bar for housing supply. The changes in the NPPF are just clarifying existing policy, rather than making substantive policy changes. However, the importance of design standards is also a key emphasis within the revised NPPF. Notably there was also strong references to design within the Communities Secretary, lames Brokenshire's, written ministerial statement when he announced the revised NPPF. He said: "critically, progress must not be at the expense of quality or design. Houses must be right for communities. So the planning reforms in the new Framework should result in homes that are locally led, well designed, and of a consistent and high quality standard." We shall see in due course how Croydon Council apply these new design guidelines.

Points to consider if a developer approaches the owner of a house for re-development

In view of the all applications to demolish houses and replace them with flats, the RRA along with a number of other local RAs have published this piece below for residents to consider if they are approached by a developer.

The RRA are aware that a number of developers are seeking to purchase houses for re-development in and around Riddlesdown (Purley & Sanderstead). These are some points below for home owners to consider. What follows, is not RRA guidance or advice and it is not aimed at specific developers or house builders. It is a generic note which sets out points that owners may wish to consider before selling their property. However, the RRA would strongly recommend that anyone in this position should always seek legal and financial advice before acting on any offer from a developer.

The RRA are receiving reports of developers expressing an interest and sending unsolicited offers for properties within Purley & Sanderstead (Riddlesdown), particularly detached houses. A number of developers have already made offers locally and Croydon Council have granted planning permission to build flats. These developers are also active in other parts of the Borough of Croydon. However, as of 31 August 2018, no new flats have yet been built in Riddlesdown.

The developers typically want an 'option' and will only complete the purchase if planning permission is obtained. Having paid around  $\pounds 5,000$  to  $\pounds 10,000$  for the option, the developer then funds the planning application process and, if successful, they have first-refusal to buy your house at the previously agreed price.

As the RRA currently understands it, if a developer approaches you, then there are some important matters to consider: -

1. The developer may not be 'purchasing' the house right now, but generally looking to lock the home owner into a contract that is likely to force a sale in 12 to 18 months' time (or longer). Only the developer can walk away from the agreement.

2. The developer can fail to gain planning permission - so they might decline to purchase your house. You get to keep the initial option money and you keep your house. Any plans you had to move elsewhere may be significantly disrupted. The developer may submit a number of variable planning applications to Croydon Council, to ensure the maximum return for them.

3. The 'option' process may create a great deal of inconvenience for the seller. Having taken

the 'option' payment, the developer may be entitled to force the sale of your house. Even if your circumstances have changed, or you have simply changed your mind once you see how much your neighbours resent the planning proposal.

4. If for any reason you need unexpectedly to sell your house urgently, you will probably be unable to do so whilst the developer holds the 'option'. You can only wait for the planning process to take place and let the developer decide.

5. We understand that some developers are currently offering a 'fixed price' for Purley and Sanderstead houses that will be paid after 12 to 18 months. You may not benefit from any uplift in the value of your property.

6. Should you be tempted to enter into an 'option' relationship with a developer you should discuss the it with your immediate family and most certainly take legal and financial advice. You should obtain independent, professional advice and ensure that you totally understand what you are committing to, and what can go wrong. If you have received assurances or been promised any concessions from the developer, then these should be in paced in writing and reviewed by your solicitor before you sign the contract.

7. If one (or both) owners die, then the situation may be more complex in respect of probate.

8. Are there restrictive covenants on your land? A lot of land in Riddlesdown does have Associations are: Riddlesdown, Hartley & restrictive covenants regulating the types of District, houses that can be built in the street, the Coulsdon West, Old Coulsdon and Kenley & number of houses in the street and on your District. building of flats. We are given to understand that the legal opinion received by some adjoining residents to plots that have already been granted planning permission, is that some of these restrictive covenants may be enforceable. But this does depend on each property and the exact wording of the restrictive covenant. It cannot be generalised. Again legal opinion needs to be sought before signing with a developer.

These are just some of the issues to consider. It is not an exhaustive list. The RRA (and a number of other local RAs) are keen to see copies of any correspondence (and terms and conditions) that any local resident may have received from these developers. Please contact the RRA if you have received an offer, which you have declined.

#### Purley Town Centre – 17 storey Tower

As I reported last time, the Secretary of State for Housing. Communities and Local Government; Sajid Javid (who has now been replaced by James Brokenshire) 'Called In' Croydon Council's decision to grant planning permission for the 17-storey Purely tower in central Purley and the associated 3 to 8-storey flat development on the south side of Banstead Rd. The Public Inquiry took place from 9 January and lasted for 6 days. It was held in the Purley Baptist Church and included a morning touring the site and adjoining areas.

This development is opposed by seven local Residents' Associations (RAs). These seven Sanderstead. East Coulsdon.



'Rule 6' status (as the lead RA) and we some of the town centre. presented our case to the Inquiry. Because we had 'Rule 6' status we were allowed to crossexamine witnesses

The Planning Inspector leading the Inquiry was David Nicholson. At the Inquiry, the RAs were represented by Charles King (East Coulsdon), Dennis King (Sanderstead), Diane Hearne & Lee Cooper (Hartley) and Phil Thomas (Riddlesdown). The planning barrister for the applicant (Thornsett & Purley Baptist Church) was Christopher Katkowski OC, and the barrister acting for Croydon Council was Stephen Morgan.

I won't repeat in full again in this issue all the points and objections that we have raised against this development, but just skip through a few of the key points that we raised at the Inquiry. Firstly, we believe it needs to be made perfectly clear, the seven RAs are not opposed to new development on these two sites. We understand that growth will be key to the future vitality and viability of the Purley District Centre (PDC). We also recognise the acute housing needs in the area and wish to see more new homes that are genuinely affordable provided for local people.

At the Inquiry, we put forward the issues which we believed were not considered sufficiently by the Council when granting planning permission. Our main issue with this development is the height of the 17-storey tall building. The RAs believe it will have an unacceptably harmful impact on the PDC and the surrounding townscape by virtue of it being at least 5 times higher than the immediate and surrounding buildings in the district centre. The tall building will sit very closely behind the pavement on the Brighton Rd frontage and create a shadowing effect on representation. We did our best and we wait

We believe that the density of the housing units is well beyond the density range in the London Plan matrix. We argued that the level of affordable housing, 18%, was low in terms of the total of 220 residential units proposed. The London Mayor's draft proposal for 'Affordable Housing and Viability Supplementary Planning Guidance. savs developments in London should in future meet a minimum of 35% affordable housing.

The two sites are on the edge of the Environment Agency's Flood Risk Zones 2 and 3. Purley Cross, on the Brighton Rd frontage, immediately outside the tower site has flooded many times in the past.

We told the Inquiry that parking is insufficient for the Church and community use. The planned auditorium will accommodate 500 people with just 50 parking spaces. There will be 28 car parking spaces for the 114 residential units. For the south side site, there will be 9 accessible car parking spaces for 106 residential units. The exit (and entrance) to the car park for the island site (church & flats), will be on Russell Hill Rd just before the traffic lights at Brighton Rd. Vehicles (including lorries) entering and exiting the site will have to cross a number of lanes of traffic. For better road safety, the RAs believe an entrance/exit should be in Banstead Rd.

We believe that the seven RAs presented valid arguments. The legal teams for the applicant and Council did congratulate the RAs for the way we put forward our presentation at the end of the Inquiry, although of course they didn't agree with our views! It was a long hard slog by a number of members of the seven RAs and we did it without any legal

the outcome with interest. Not everyone will agree with the RAs' views, (a few did speak at the Inquiry supporting the scheme. Many more members of the public spoke at the Inquiry, and it was clear that there is strong local opposition to this scheme.

In early May, we were made aware that the Planning Inspector had sent his report and recommendation to the Secretary of State. The Secretary of State can overrule his recommendation. We were expecting a final decision around 6 August. However, at the end of July, the Secretary of State's office advised us the decision had been delayed because on 24 July the Government published a new National Planning Policy Framework (NPPF) 2018 which would be taken into account from the date of publication for all planning applications.

The Secretary of State's Office gave all three parties until 13 August to comment further, as to whether we thought the new NPPF 2018 included new information which may be material to the application before him. There was then a further 7-day consultation period after the submissions were sent to the Secretary of State. A further response was submitted on 17 August by the RAs, to the Secretary of State's Office, after we saw the submissions of the other two parties. The Secretary of State gave notice that we should expect a decision on, or before 13 September 2018 but a day or so before this date, we received an e-mail to say it had been postponed indefinitely. We will post the decision on our website and Facebook page, when it happens!

#### ENVIRONMENTAL ISSUES BY PHIL THOMAS

#### Litter Picks in Riddlesdown

The RRA had another successful litter pick on 7 April when about 25 people (including 5 children) collected about 30 bags of rubbish. 2 tyres, a trolley an old bike and other metal. A good effort was made and Dunmail Drive, Mitchley Ave and the footpaths on the farmer's field opposite the shops had a good spring clean. Thanks go again to Tracey Bellamy, the Council's Street Champion Coordinator, and Dermot Linehan from Croydon Council for assisting.

Tracey has also been in contact with staff members at the Collegiate and on 23 May, around 30 students from Riddlesdown Collegiate carried out a litter pick on land near to the Collegiate. They collected 15 bags of general waste and 5 bags of recycling. The students had identified for themselves the type of litter they thought they might find and where it would be. At the top of the list was plastic bottles and crisp packets. The Officers took advice from the students, where the litter pick should start and this included the farmer's grass field leading down to the Mitchley Ave shops (the students call it the 'Cornfield'), the White Path, Dunmail Drive and onto Riddlesdown Common. The students reserved the recycling collected for use in an assembly which was carried out with the support of the Recycling Education Officer from Croydon Council.

Further litter picks were carried out with by Riddlesdown Collegiate with about 90 front of this property. It was created by the students participating over 3 days at the end Council's of June and early July. The litter picks were November when they installed a vehicular

again overseen by Tracey Bellamy. The students collected 75 bags of litter including a set of brake discs and the boxes they came in! We are told that the students were fantastically well behaved and separated the waste for landfill and recycling. They are now working on posters which the Council hope will be used in the new 'Big Belly' bins promotion. Riddlesdown Collegiate have given their support for future litter picks each term.

Tracey also noticed that the waste bin on the Dunmail Drive junction to Honister Heights was overflowing on two occasions, so she has arranged for this bin to be replaced with a 'Big Belly' bin. Hopefully, this will capture more litter and notify Veolia when the bin is full. The RRA and local residents are always complaining to the Council about this overflowing waste bin, so this is good news. I hope most local residents will appreciate the commitment that the Collegiate staff and pupil are making to clear litter from the local environment.

The next RRA litter pick will be on Saturday 17 November at 2pm. If you can come, please meet at the bottom of Dunmail Drive at the junction with Mitchley Hill. There are no Premier League football matches on that day!

#### 42 Riddlesdown Ave – Footway Crossover

As I reported last time, the RRA have written and raised serious concerns with the Council about the steep cross fall on the footway in Highways Department last

crossover and dropped kerb to the front of The RRA remain concerned that pedestrians this property, which is situated at the top of a very steep grass bank. There is about a 900 mm height difference between the road level at the gutter and the hardstand on the property.

The RRA are concerned about the steep crossfall for the elderly, able-bodied and the disabled. We are told by local residents that it was extremely slippery and dangerous in the cold and icy winter. We asked 'Disability Croydon' to look at the footway in June and give their views. They were horrified at what had been done by the Council and wrote a strong letter of complaint to the Director of Streets, at Croydon Council. The Council have now carried out a land level survey, (which they should have done at the outset). We are continuing correspondence with them. We hope that they will re-design it and implement some remedial works soon!

#### **Mitchley Ave Accidents**

Despite the Council laying a better skid resistant surface on the bend of Rectory Park and Mitchley Ave last November, accidents have continued to occur, although not as many as previously (ten accidents in the last two years). We are aware of at least two since November. The first was in March, when a vehicle demolished the lamppost and street sign on the outside of the bend. Another accident occurred in wet condition in early August. A driver lost control of his or her car after the bend and hit a car parked on the opposite side of the street. We are not aware of any serious injuries from either of these accidents. We do know, however, that during the latest incident, a local resident who was walking with his dog, had a near miss.

and/or schoolchildren walking by this bend will be seriously injured, or killed, particularly when walking on the pavement on the outside of the bend by the wooded area. We have again taken the matter up with the Council and await their response.

#### **New Wheelie Bins - Update from Croydon Council**

As our Chairman Brian Longman has said in his report, new wheelie bins came into operation at the beginning of September for refuse and recycling. When we met with Cllr Stuart Collins and a senior Council Officer in Riddlesdown in July, the RRA asked a number of questions to the Council. Our questions and the council's responses are as follows:

Q - For those who completely fill the 240 litre wheelie bins, has a health and safety audit been undertaken by the Council, on the weight of a wheelie bin, i.e. if it is completely full with heavy magazines, newspapers etc., can it be moved easily? These bins will be very heavy to manoeuvre (especially for the elderly) up or down steps and/or up and down slopes with the risk of accidents and injury to residents.

A - A full recycling bin should not prove any



more difficult to manoeuvre than a full landfill bin An assisted collection is available for anyone who meets the criteria and can be booked by calling the customer contact centre.

Q - What is meant to happen with shredded paper? The Council now say don't put it in the blue top wheelie bins!

A - Shredded paper can be placed in paper bags, or envelopes and put into the paper recycling bin. The Council's website has now been amended to cover this https://www.croydon.gov.uk/.../recyclingcollec.../house-recycle

RRA footnote – Primark are one of the few shops, or supermarkets that we know hand out paper bags!

Q - Why haven't the Council supplied stick-on house numbers for each wheelie bin, as they did in 2005?

A - This was not budgeted for and would have added to the time taken to deliver the bins. Residents who wish to stick house numbers on their bins are welcome to do so at their own expense.

Q Why can't Croydon do a mixed recycling collection in one 240-litre wheelie bin, as many other Local Authorities do? These Councils obviously have the resources to separate the materials at the recycling facility! So why haven't SLWP/Croydon/Veolia?

A - The quality of material collected tends to be much worse from mixed, or as is known in the industry as "fully co-mingled" recycling streams. This means contamination rates are higher, meaning less waste is actually recycled and the recyclable material is less valuable as a commodity "twin stream" recycling, on the the new wheelie bins is approximately the other hand, keeps the most valuable same as the boxes. If you currently have the

commodity, the paper, separate so it is clean and uncontaminated and therefore both the paper and recycling stream have the best chance of being recycled and retaining maximum value

Q - Many households currently have the 'standard' 180-litre general waste bin. It appears, however, that the Council have delivered 140-litre rubbish bins even though they are marked '180 litre'! They appear to be smaller wheelie bins.

A - Different manufacturers use different dimensions for their bins, however the landfill bins that have been delivered definitely hold 1801

To mark this event, 45cm poppies have been displayed on some lampposts in the Borough of Croydon.

The RRA along with a number of other Residents' Associations of Sanderstead. Selsdon, Coulsdon West, East Coulsdon, Old Coulsdon, Hartley & District, and Kenley & District have fixed poppies on lampposts to some streets in their areas. In the Riddlesdown area, this is in Rectory Park, Mitchley Ave, Lower Barn Rd and Coombe

(who maintain the street lighting) have been very supportive in allowing all the Residents' Associations to do this

#### TRANSPORT BY JOHN RAPP

Since 1st September 2018, the 412 bus service has been severely reduced. The revised Timetable is available on the RRA website.

We have been talking to Transport for London since the announcement of these changes in August, and - following the September Committee Meeting - we have invited a senior member of their Bromley and Croydon Team to the 2019 AGM to make a presentation and to answer Residents' questions.

It may be that you would wish to comment on these changes sooner. The TfL website includes options to comment online or via Facebook or Twitter. It is also possible to telephone on 0343 222 1234 or to write to TfL Customer Services, 4th Floor, 14 Pier Walk, London, SE10 0ES.

September, an amended Purley termination arrangement for our 412 bus service. Currently the bus reaches Purley Tesco (the stop is named Purley High Street / Purley Station) and then continues to the Downlands Precinct and Purley Hospital stops before it runs out of service to Purley Oaks on its way to the bus stand opposite Purley Hospital ready to start its next journey. From September, after stopping at Tesco the bus will run in service to the Banstead Road stop (for the 405 towards Croydon) continuing in service (with passengers) to the bus stand. It is important for that section of route to be seen to be used, as currently, London Buses are shaving their costs by reducing the number of buses running on outer London Routes. I understand that on the 412 there will be one fewer bus running. Once the Elizabeth Line is fully open, many Central London buses will be

available to be cascaded to Outer London.

There has been a lot of publicity about the problems that have occurred in the wake of the roll-out of Thameslink's Timetable on 20th May. Knowing that Riddlesdown is served by both Southern and Thameslink trains and that any problems with one service impact on the other, we have obtained comment from Govia Thameslink Railway (operating both).

"An interim Thameslink timetable was introduced on 15 July to provide a more reliable service to passengers following the disruption to train services since the original timetable change on 20 May. It seeks to provide a plan that we can operate reliably with fewer on-the-day cancellations allowing passengers to plan with greater certainty. This interim timetable includes more trains than we were running prior to 20 May but does not include all those we had planned to run from 20 May. We aim to restore those services as quickly as possible starting with the high peak services (arrivals at London terminals between 0730 and 0830; departures between 1730 and 1830), then the rest of the peak, then Monday-Friday off-peak services. This will happen progressively from September. We are

sorry for the disruption since 20 May and would like to assure you that we are working hard to return to a stable service, and to provide the planned service we hoped to put in on 20 May as soon as possible."

As additional support and comment they have mentioned that latest information is always on www.nationalrail.co.uk, and that the Office of Rail and Road (ORR) has set up an inquiry into the background of the May Timetable changes. GTR has mentioned that it is worth checking here on the day of travel too for any last minute issues.

From time to time I mention that public transport does respond to demand or lack thereof: the concept of "use it or lose it". I expect that GTR will use the train loading data – the passenger weight of each carriage is a reported item - to establish which missing trains need to be re-instated first.

I end by wishing all our residents who use public transport successful journeys.

#### MP's Report Chris Philp Waste and Recycling Changes

The council are planning major changes to waste and recycling collections. Currently we have a black wheelie bin for waste, two recycling crates (green and blue), a garden waste wheelie bin if you have paid for that and the small food waste box.

The council is now planning to provide a third wheelie bin to replace the current blue crate and a fourth wheelie bin for general waste – with the old black waste wheelie bin then replacing the green crate (I was confused at first too!). This means that if you pay for the green waste service you could end up with four large wheelie bins at your property.

I have joined local councillors in asking the council what to do with the old blue and green crates. We were told there might be one collection of them – so we could end up with the borough strewn with abandoned crates. With four large wheelie bins and leftover crates, there are legitimate concerns that local people's homes could end up looking like a municipal recycling centre.

#### More NHS funding for Croydon

Croydon's NHS has recently received a  $\pounds 12$ million funding boost for local services and help care for people out of hospital. This will really help our local area, and comes as the  $\pounds 21$  million re-build of Croydon University Hospital's (Mayday's) new A&E nears completion. A year ago, Purley Hospital's Minor Injuries Unit/GP Hub extended its

opening hours to 8am-8pm 365 days a year, adding the range of services offered in our neighbourhood.

The recent announcement by the Government of a  $\pounds 20$  billion long-term increase in NHS funding across the UK will help healthcare in Croydon for many years to come.

The NHS looks after us all when we need it. I will keep fighting to make sure that Croydon gets its fair share of resources and that our local facilities keep improving.

#### School funding increases

Following lots of campaigning, Croydon schools are getting an  $\pounds 8.9$  million (3.9%) increase in Block funding from the Government this current financial year nearly double the rate of inflation. Larger secondary schools are getting especially big increases in block funding - such as Oasis Coulsdon Woodcote (16%).(8%). Riddlesdown (5%) and Harris Academy Purley (10%).

Some smaller primary schools had smaller increases (and in a few cases a reduction) even though Croydon's government funding for schools went up quite a lot. This was due to the way Croydon Council divided up the funding between schools.

I am working with the council and some of the schools affected to try to find a way to resolve this issue for the next financial year.

Southern and Thameslink timetable fiasco

After slow improvements in the service over the last year, the introduction of the new timetable for Govia Thameslink Railway (GTR) services on 20 May has been a fiasco.

Many Thameslink and Southern Rail trains

have been cancelled or removed and there is now a revised cut-down timetable. Despite the fact that the new timetable has been longplanned, GTR has failed to provide enough drivers on the new routes.

This reinforces my long-standing view that GTR should lose the franchise, which I have put to the Transport Secretary in the House of Commons.

GTR's Chief Executive, Charles Horton, has resigned, but I am pushing for the whole franchise to be taken away from GTR due to their serial incompetence.

#### Councillor's Report Helen Redfern

I was delighted to be elected as one of the two councillors for the new ward of Purley Oaks & Riddlesdown, a ward that stretches from Pampisford Road in the north down to Riddlesdown Collegiate in the south. The southern section of our ward is covered by Riddlesdown Residents' Association.

I already know a lot of residents in the ward, as neighbours, as parents of children at the same school and members of the congregation of St Mary's Church Purley Oaks. I've spent the first few months in my new role meeting as many people as possible. Riddlesdown Residents' Association has helped me to engage with a number of residents, as have neighbouring associations in the north of our



ward. We've had the first meeting of the vulnerable residents have not be fully Purley Oaks and Riddlesdown Police Ward Panel which was well attended but there is space for more people and I would especially like to see more young people attend so we can include their perspective and serve their needs. I've also attended some great local events such as Croydon Classic Car Show in Rotary Field and Purley Food and Drink Festival on Purley High Street.

My (mostly email) post-bag has included a number of interesting cases raising questions ranging from the provision of school places to concerns about care for elderly relatives. However, the two key issues have been the new recycling system and planning issues:

By the time you receive the Recorder, the new waste-management/recycling system will be in place and hopefully any surplus blue and green crates will have been collected. There have been concerns about how this will operate in practice, including a lack of space for 2 more wheelie bins, which can make a total of 4 or 5 depending on whether you also pay the additional amount for green waste collection, to why such a big bin is required for paper recycling when most of us have struggled to fill the small blue crate previously. At the Council Meeting of 9th July I asked the Cabinet Member responsible for this new initiative about its practical application in some Riddlesdown Roads where house frontages are particularly hilly or stepped. After much correspondence and a site visit with the RRA, we have made some progress on adapting the process for some of the more challenging addresses. There has also been a need to provide assisted deliveries to residents who are unable to manage the bins themselves. I agree with others that the needs of our more how to use this budget.

considered in this process. I strongly hope that by the time you read this, things will have settled, and if not, I'll be working hard to get things right.

Planning continues to be a significant issue in our ward. The greatest concern has been the growing trend for developers seeking to demolish an attractive family home in order to replace it with a much bigger building accommodating 8 or 9 flats - that number is significant as this means the developer isn't required to provide affordable housing. The applications generally provide fewer parking spaces than there are flats, which means that our roads have to absorb the extra parking. That is a particular problem in Riddlesdown because of the high level of parking demand in the vicinity of Riddlesdown Station but also because a lack of spaces means there are less passing spaces in the roads south of Mitchley Avenue – where traffic often grinds to a halt around the start and end of the school day at Riddlesdown Collegiate. Simon Hoar and I will continue formally to object to inappropriate planning applications but it should be noted that the Council's Planning Committee appears keen to pass as many of these applications as possible. We remain concerned about the impact this will have on the character of our lovely area.

Are you aware that each councillor has a Community Ward Budget of £8,000 p.a. to spend on one-off projects that improve the well-being of the local community? #### Councillor's Report Simon Hoar

The new Purley Oaks and Riddlesdown ward came into existence at the council elections on May 3rd. The ward is an amalgamation of areas previously that previously formed part Sanderstead, Purley and Waddon wards and runs from Riddlesdown school in the south. northwards over Mitchley Avenue, along Brancaster Lane and Riddlesdown Road then widening out to take in Purley Oaks station, Purley Rotary Field and up to Pampisford Road and the borough boundary with Sutton.

Since being elected to represent the new ward, two of the most active areas of casework I and my colleague (Helen Redfern) have received have been around planning applications and the new refuse system being brought in for September.

The three wheelie bins are causing a lot of concern in Riddlesdown, from storage problems, to the visual blight of so many bins on our streets and frail residents worried about whether they will still receive their assisted collection. If you also pay for the garden waste service this means four wheelie bins lined up outside your house. Personally I think this change is overkill but the current council administration who took office in 2014 have taken Croydon's recycling rate from approximately 45% of all waste down to 38%. I feel a better solution would have been to improve the collection, and to expand the from one of family homes to one far more

materials collected, as happened in past years. The good news is that the assisted collection does remain, and the council are finally improving the recycling system for flats. I lived in a flat above shops on Brighton Road for many years and had to collect and recycle everything at Purley Oaks myself, so improving collections from flats is welcome. If you live in a house and it really is impractical to have three wheelie bins (Riddlesdown is a hilly area after all) then the Council have said it is possible to be exempted, and some areas have been. Please let me know if you think this could apply to you and we can get the Council to investigate.

The other big issue is over planning applications, usually for blocks of flats. Within the wider ward there is an issue with the Council's Brick by Brick development company and those who have been along Montpelier Road recently will have seen the hoardings in place for a flatted development up to six stories on the side of the hill.

In Riddlesdown and into Sanderstead and Purley, the problem is more with small developers applying to remove single homes in favour of blocks of eight or nine flats. Current schemes include sites on Riddlesdown Road, Mitchley Avenue, Brancaster Lane and down onto Oakwood Avenue, Selcroft Road and Grasmere Road, I am very concerned about the impact that this has on the area. It not only makes the roads more congested, but also the construction of flats changes the nature of an area. Individually these schemes make little difference (and planning law requires each application to be judged on its own merits), but the cumulative effect risks damaging the nature of our area



urban. Riddlesdown is a lovely place to live, full of family homes and I'm sure we would prefer to keep it as such a nice place. If you hear of a such a scheme near you, please let us know.

It has also recently come to light that TfL intend to cut the frequency of the 412 bus from four an hour down to three from 1st September. On most of its route this is less important due to the availability of other routes, but for Riddlesdown the 412 can be a public transport lifeline. I understand that TfL intend to consult on the changes at some point (after they have implemented the change!); please join us in letting them know any comments you have. At the time of writing this piece, I have asked the London Assembly Member to take up the issue with TfL and I will be asking the Council to do the same for the residents of Riddlesdown.

As we prepare to embark on another academic year at Riddlesdown Collegiate, we are celebrating another set of fantastic exam results this summer. At A Level, almost half of all grades were A\*-B and 12 students achieved straight A/A\* grades in at least 3 subjects. The vast majority of them have been successful in gaining places at their first choice university and we wish them the very best of luck as they begin the next chapter of their lives. Meanwhile, at GCSE, students achieved outstanding results with 92% passing English at grade 4 or better and 80% passing Maths at grade 4 or better.






